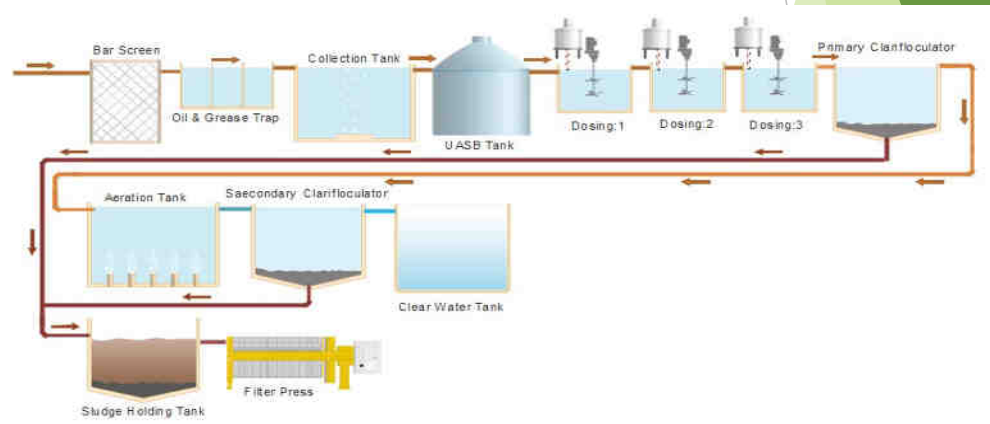

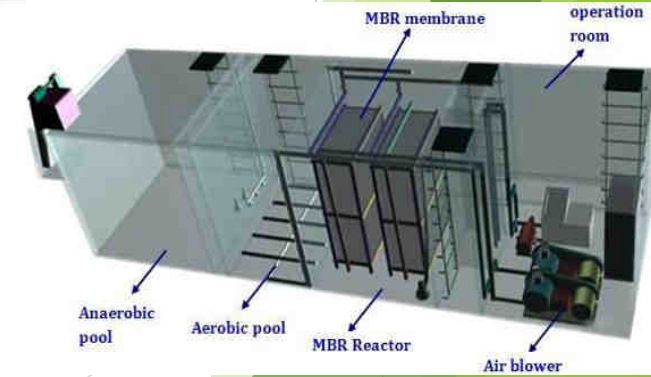

Water Treatment Plant
